Or, if you begin to show symptoms whilst on site, you will exit the Site immediately. **Card access will be suspended as of 1 December 2021 unless a declaration is received.**

Failure to do so may expose other Market Users to risk and cause injury, loss or damage.

SAPML reserves the right to take any action it considers appropriate against a person who makes a false declaration which may include indefinite exclusion from the Market and a claim for compensation for any loss or damage that is caused.

PRIVACY COLLECTION NOTICE

The sensitive and other personal information on this form is collected by South Australian Produce Market Limited ACN 008 129 566 (SAPML, we, us, our) to manage our response to the current COVID-19 pandemic. This includes managing access to the market premises, assessing and managing COVID-19 risks posed by market participants, keeping market participants informed of COVID-19 matters related to the market and for our internal business functions such as dealings with our suppliers. If you do not provide some or all of this personal information, we may refuse you access to the market premises.

We may also collect other sensitive and personal information from you, and from third parties, such as your employer, other market participants, government authorities and as otherwise required or authorised by law, for the purposes described above. Where this information is sensitive information related to COVID-19 matters you consent to this collection.

We may use and disclose your personal and sensitive information for the purposes described above and for other directly related purposes that you would reasonably expect. For example, this may include disclosures relating to your COVID-19 status or risk to your employer, other market participants, government authorities. In addition, we may use and disclose your personal information and sensitive information for other purposes with your consent, or where otherwise required or authorised by law. Generally, all recipients are located in Australia, but we may make disclosures to overseas recipients where required or permitted by law.
