SA FARMERS MARKET CONDITIONS OF ENTRY - MARKET RULES

1. APPLICATION

- 1.1. These are the Market Rules which to all attendees at the Market (except Vendors who have separate and more comprehensive Rules apply to them). In short, these Rules apply to all members of the public.
- 1.2. It is a condition of entry to the Market that all attendees agree with South Australian Farmers Market (SAFM) to abide by these Rules. If an attendee does not agree to abide by these Rules, the attendee may and must leave the Market within 15 minutes of entry to the Market.

2. GENERAL

- 2.1. Access to the Market is only permitted during the Times of Use.
- 2.2. The Times of Use may be amended for Market Days by SAFM and, in particular, are subject to the Weather Policy.
- 2.3. Attendees must park their vehicles in the areas designated for parking by members of the public and in no other area. In particular, attendees must not park in the market area.
- 2.4. Speed limits of vehicles must be observed at all times. The speed limit for all vehicles at all times is 20km per hour, unless a lesser speed limit applies.
- 2.5. Attendees must abide by all traffic management plans of the Market and all traffic directions of SAFM.
- 2.6. Attendees always obey all signs (and in particular, traffic signs) erected or installed at the Market.
- 2.7. Attendees must comply with all directions of SAFM and the Market Retail Manager.
- 2.8. Attendees are not permitted to access areas outside of the market square and may be removed from the market square or the Market site if they do so.
- 2.9. Rubbish and other waste may only be placed in the bins or other receptables set aside for waste, and may be placed only in the type of receptable marked for that type of waste.
- 2.10. The Market is a non-smoking venue.
- 2.11. All attendees must be sober (and not under the influence of a controlled substance) when at the Market, and may not consume any alcohol or a controlled substance whilst at the Market.

- 2.12. Guide dogs, assistance dogs and dogs in training are permitted inside the Market site. All other animals are prohibited.
- 2.13. The attendee must not carry on any offensive or dangerous activities on or from the Site or create a nuisance or disturbance to other attendees or any other Market user.
- 2.14. Should an Emergency Management Directive be issued under the Emergency Management Act 2004 (SA) then these Rules are subject to change without notice.
- 2.15. Fees, as determined by SAFM, may apply for a breach of these Rules. If an attendee is required to pay a fee for a breach of these Rules, SAFM will give the attendee written notice of the Rule which is breached and the applicable fee.
- 2.16. SAFM has the right at any time to eject, refuse admission and ban from future admission at the Market the attendee, where the attendee breaches any of these Rules.

3. WEATHER POLICY

3.1. BACKGROUND

The Market is an all-weather market, however the hours of trading may change or the operations for any Sunday may be cancelled due to catastrophic or other unforeseen weather conditions e.g. extreme heat, strong winds, catastrophic bush fire warnings and bushfires, heavy rain and flooding.

3.2. POLICY

Decisions can made in relation to weather conditions on Market Days or in advance based on weather warnings issued by the Australian Bureau of Meteorology, State Emergency Service and/or the Country Fire Service

The decision to vary the hours of, or close, the Market on a Market Day is at the sole discretion of SAFM.

4. RISK

- **4.1.** The attendee enters the Market at his or her own risk and agrees that SAFM is fully released from all responsibility and liability from any claim, demand, damages or action in respect of:
 - loss or damage to the attendee's property;
 - death of or injury to the attendee; and
 - any incident, damage or injury on or about the Market,

- except where directly caused by the negligence of SAFM.
- 4.2. SAFM is not responsible for any theft at the Market (including from the attendee's vehicle).
- 4.3. Attendees are solely responsible for the quality of all products and produce sold at the Market. SAFM is not responsible in any manner whatsoever for any product or produce purchased at the Market or any other transaction made or effected at the Market.

5. SOUTH AUSTRALIAN PRODUCE MARKET REGULATIONS

The attendee shall perform and not breach the South Australian Produce Market Regulations (a copy of which is available upon request), so far as the Regulations are potentially applicable to the Market. In particular, the attendee must not breach the vehicular speed limit within the Market, must abide by all other traffic requirements and directions set out in the Regulations, and must abide by all safety requirements.

GENERAL

- 6.1. For the purposes of these Rules;
 - 6.1.1. 'attendee' is a member of the public who attends the Market (other than a Vendor who has a licence to use a Site for the particular Market Day).
 - 6.1.2. 'SAFM' means SA Farmers Market Pty Ltd ABN 84 609 016 015 and includes any officer, employee, agent or contractor or related corporation of that entity, and the Market Retail Manager;
 - 6.1.3. 'Times of Use' means the period commencing on the advertised opening time and expiring on the advertised closing time of the Market to the public;
 - 6.1.4. The Market Retail Manager may exercise any right of SAFM under these Rules, including giving a notice or direction or exercising a discretion.
