I agree that by completing and submitting this waiver and participating in the Charity Soccer Match Coopers Stadium, Hindmarsh on Friday 12 April 2024, (**Match**) that I have voluntarily accepted and assumed all of the risks of physical injury, including by way of example and not limitation, serious injury such as permanent disability, paralysis or even death by my participation in the Match. I acknowledge that I am voluntarily participating in the Match with knowledge of the potential dangers and/or risks involved, whether those risks are known or unknown and however caused.

I agree that this General Release and Waiver will be used by South Australian Produce Market Limited (**SAPML**), Market Fresh SA Pty Ltd (**Market Fresh SA**), Adelaide United Football Club Pty Limited ACN 136 768 539 (**Adelaide United Football Club**), Impeach Pty Ltd ACN 008 143 959 (**Foodland Promotions**) and that it will govern my actions and responsibilities at the Match.

As a condition of being allowed to participate in the Match, I, both for myself and for my executors, administrators, heirs, next of kin, successors, and assigns agree that I hereby irrevocably waive, release, discharge and forever hold harmless SAPML, Adelaide United Football Club, Foodland Promotions and Market Fresh SA, and any of its related entities, officers, directors, employees or agents and their successors, assignees and transmittees (together the **Released Parties**) from any and all liability, costs, loss and damage, including but not limited to, liability arising from the negligence or fault of the Released Parties, for my death, disability, personal injury, property damage or actions of any kind which may occur to me or be incurred by me in connection with my participation in the Match.

I acknowledge and agree that:

- (i) I certify that I am physically fit and that there are no health-related reasons or problems which preclude my participation in the Match;
- (ii) the Released Parties do not (either alone or together) have in place any personal accident insurance policy or other insurance policy that would provide me with any compensation, coverage or benefits as a result of my participation in the Match; and
- (iii) subject to (iv) below, I have private health insurance (inclusive of ambulance cover) that would extend to my involvement in the Match; and
- (iv) if I do not have private health insurance (inclusive of ambulance cover), I alone will be solely responsible for any and all medical and all other ancillary costs that may arise as a result of my participation in the Match.
- (v) for the purposes of the *Return to Work Act 2014*, the Released Parties do not consider that my participation in the Match arises out of or in the course of my employment. Participation is entirely voluntary and the Released Parties do not encourage (or discourage) my decision to participate.
